ORDER


1. In compliance with the undertaking dated 02-12-2023 in the matter titled above, Shri Narender Thakur, authorized signatory for the appellant is present, today, with the formal appeal in the matter. S/Shri Wishve Bhaskar, ACST&E (Legal Cell) and Amit Kashyap, ASTEO, Collector Office South Zone present for the Respondents. The appellant submits that entire pending license fee for the month of October 2023 in respect of Licenses in Form L-2/L-14 Rohru Unit for the Year 2023-24, already stands deposited and further submits that, in view of above, the impugned order dated 02-12-2023, passed by the Collector Excise in Excise Case No. 287/2023-24, along with subsequent proceedings may be rendered infructuous.



2. The representatives for the respondents admit that the entire pending license fee for the month of October 2023 stands deposited.
3. In view of above, as nothing remains to be adjudicated, therefore, the impugned order dated 02-12-2023, passed by the Collector Excise in Excise Case No. 287/2023-24, along with subsequent proceedings are rendered infructuous. Notwithstanding the fact that the appellant has deposited the due license for the month of October, 2023, the appellant is liable to pay interest, penalty and/or any other dues leviable under the applicable HP Excise Act, 2011, Rules, Orders and ANNOUNCEMENTS FOR THE ALLOTTMENT OF RETAIL EXCISE VENDS BY AUCTION-CUM-TENDER FOR THE YEAR 2023-24. Ordered accordingly.
4. In view of dismissal of this appeal, the Miscellaneous Application, if any, is also disposed of.
5. All the concerned parties be informed and the file after due completion be consigned to record room.


