**ORDER**

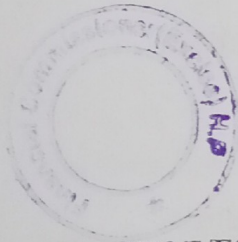




approval in respect of Vends which remained closed for some days.
