ORDER

The Government of Himachal Pradesh vide letter No. EXN-F(1)-1/2019, dated 16th August, 2021, has conveyed to the office of Commissioner of State Taxes & Excise, Himachal Pradesh the approval of abatement of licensee fee in respect of some retail licensees for the years 2017-18 and 2018-19. The above appellant/licensee is enlisted at S. No. 6 of the conveyed list of approval in respect of Vends which could not operate due to their shifting from National Highways.



The Zonal and District In-Charges, vide office of the Commissioner of State Taxes & Excise, Himachal Pradesh letter No. 7-771/2017-EXN-1889-1901, dated 20 January, 2022, have already been informed regarding above approval of abatement of licensee fee in respect of retail licensees for the years 2017-18 and 2018-19. The In-Charges have, further, been directed to take further necessary action in the matter, accordingly.

In view of facts above, the present appeal has become infructuous, and is being dismissed as such. Let the parties concerned be informed.
