## Appeal under Section 45(2) of the HP VAT Act, 2005 Order

1. The present appeal has been filed by M/s Hans Raj HP Center Kandrori, Tehsil Indora, Distt Kangra Himachal Pradesh against the orders of Jt. Commissioner of State Taxes & Excise-Cum-Appellate Authority North Zone, Himachal Pradesh, dated 22-12-2021 vide which the appeal filed by the applicant against the order dated 19-10-2019 of the Assessing Authority Cum-ACST&E Damtal at Kandrori (Respondent Number 2) was dismissed on ground of non-deposition of Rs. 3,71,700/- within the prescribed time against the total demand of Rs. 12,39,000/- for the Years 2017-18, 2018-19 & 2019-20 created by the Assessing Authority.

- 2. The Appellant prayed to waive conditional amount as directed by appellate authority as his financial condition is not permitting to deposit the amount. Before entertaining the appeal, the appellant was directed to deposit remaining Rs 3,11,700/- as only Rs. 60,000/- pre condition amount was deposited till date, against the additional demand as conditional amount for admission of appeal. He requested for more time to deposit the aforesaid amount on 28-03-2023. The request for the appellant was considered sympathetically till date and matter was again called on 04-07-2023.
- 3. Various opportunities have been provided to the appellant to deposit aforesaid conditional amount. The case was called again today on 04-07-2023 and the appellant again failed to show proof of deposit of the aforesaid conditional amount. Hence, the appeal is dismissed in default for non-deposit of the requisite conditional amount.
