OFFICE ORDER



The officials shall submit their option for fixation of pay under saving clause of F.R. 22(1) a (1) within one month from the date of issue of the order.

The officials so promoted as clerks will have to qualify the typing test on computer with a minimum speed of 25 words per minute in English Typewriting or 20 words per minute in Hindi Typewriting within the probation period and if the candidates fail to qualify the typing test within the prescribed period, their probation period will be extended. During this period the incumbents will get one more chance, however, if the candidates still fail to qualify the typing test in the extended period, they will be reverted back from the post of clerk(s) to class-IV post(s).

The above officials shall be required to join their new assignment and submit their joining report within a week at the new place of posting(s), failing which it shall be presumed that the officials are not interested in promotion and the offer shall stand withdrawn and shall be debarred from promotion for a period of one year.


