

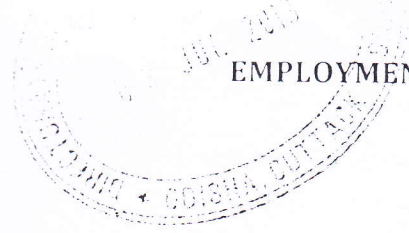

The Fee Structure for Government/Government Aided Diploma Institutions was last time prescribed vide this Department Resolution No.8222 dated 09.06.2010 for the Academic Session 2010-11 & 2011-12.

With a view to fix up a revised Fee Structure from the Academic Session 2013-14 in respect of Government/Government Aided Diploma Institutions, Government was pleased to constitute a Fee Structure Committee vide this Department Order No. 1174 dated 18.02.2013 to recommend a detailed fee structure including the Tuition fee, Development fee, Hostel Rent, training & placement fee, Caution Money and all other fees to be collected from the students.

The Fee Structure Committee so constituted after thorough deliberations and examination of existing fee structure have recommended the following Fee Structure for the Government/Government Aided Diploma Institutions for the academic session 2013-14 to 2015-16.

O.(T.T.)

After careful consideration of the recommendations of the Fee Structure Committee, Government have been pleased to approve the same and has decided that the said Fee Structure will be applicable only to the fresh/new students who will take admission during the academic session 2013-14, 2014-15 and 2015-16 and the same Fee Structure cannot be revised till he or she completes the course.

A. Institution Fees per Annum

B. Hostels Fees per annum for all years:

Electric, Seat Rent	2000
Contingency & Development Fee	1000

1. The electricity and seat rent remain unaltered in view of the increased electricity dues and Hostel maintenance.
 2. The tuition fee component of institution fee structure and electric & seat rent component of hostel fee structure will be deposited to Government Account.
 3. Other components except welfare fund contribution fee shall be deposited in the P.F. account of the institution. The student welfare fund contribution fee shall be deposited in the account of SCTE&VT, Odisha, Bhubaneswar.
- The present Fee Structure recommended by the Committee is applicable for 3 years i.e. 2013-14 to 2015-16.

Institutions are not allowed to charge any other fee in whatever name other than the Fee Structure prescribed above.

Any clarification to the above fee structure, if so necessary, the decision of the Government in Employment and Technical Education & Training Department is final and binding for all concerned.
