Sir,

In inviting a reference to your letter No.7609 dated 04.07.2016 on the above noted subject, I am directed to say that after careful consideration of your proposal vide letter under reference, Government have been pleased to prescribe the following guideline for admission into General ITIs and Special ITI at Jatni, Khurda :

The PWD candidates with prescribed educational qualification, (i). age & having 40% and above of disability shall only be considered for admission into general ITIs against 3% reservation of seats in the trades as have been stipulated by NCVT, New Delhi for various categories of disability for NCVT or SCTE&VT pattern of trades or any other short term skill development training courses; and

(ii). The PWD candidates with prescribed educational qualification, age & having 60% and above of disability shall only be considered for admission into special ITI for PWD, Jatni, Khurda in any of its trades as have been stipulated by NCVT, New Delhi for various categories of disability for NCVT or SCTE&VT pattern of trades or any other short term skill development training courses.

You are therefore, requested to accordingly conduct admissions of 2. PwD candidates into General ITIs and Special ITI for PwD at Jatni, Khurda w.e.f. current academic session 2016-17.
