Sub: Implementation of "ITI Trainees Welfare Scheme" for the trainees of all Government ITIs with effect from the academic session 2021-22.

Sir,

In inviting a reference to your Letter No. 7001 dated 20.05.2020 and subsequent proposal endorsed vide File No. DTET-CTII-SCH-0027-2021 on the above noted subject, I am directed to say that, keeping in view the multiple scope of benefits of the above mentioned proposed scheme and taking into consideration the interest of the students, Government after careful consideration have been pleased to decide for the introduction of "ITI Trainees Welfare Scheme" for the trainees of all Government ITIs with effect from the academic session 2021-22 with the following terms, conditions and modalities:

1.Rs100/- per trainee per annum shall be collected from all trainees admitted into Government ITIs at the time of admission towards ITI Trainee's Welfare Scheme'.

2. The funds thus collected shall be deposited into the dedicated account of DTE&T, Odisha as a revolving fund and maintained with proper books of account.

3.DTE&T, Odisha shall release the assistance to (a) the family members of deceased trainees or (b) to the trainees themselves in case of accident or in case of death of earning members of family, as enumerated below:

a. Assistance @Rs2.00lakhs to the father/mother in case of death of trainee during the period of training in ITI.

b. Assistance @Rs50,000/- per trainee in case of accidents caused during training in the ITI workshop which has caused permanent disability to the trainee.

c. Assistance @Rs2,000/- per trainee per month in case of death of earning father (in the case mother is not earning) / earning mother (in the case father is not earning) during the remaining period of training in ITI

d. Assistance @Rs1.00lakh in case of death of trainee during the period of apprenticeship training in apprenticeship establishments.

4. For all the cases, there have to be proper recommendations by the ITI level committee comprising TO(s) and Senior ATOs under the Chairmanship of Principal which will make adequate scrutiny of the representations for sanction of assistance by DTE&T, Odisha.

5. The scheme will be implemented from the academic session 2021-22.

6. Any clarification in the above matter, if so required, the decision of the Government in SD&TE department is final and binding.

You are, therefore, requested to please circulate the above decision of the Government among all concerned and take immediate further necessary course of action following the Government decision to above effect.
