RESOLUTION

No. SDTE-ITI-SCH-0009-2017- 4950, SDTE,
Bhubaneswar, Dated the 29th October, 2021

Sub: Continuance of the scheme 'SUDAKSHYA' as a regular scheme for improving Girl's enrolment in Government ITIs.

With a view to empower girls and young women by providing technical and vocational training to them and taking into consideration the recommendation of the SFC in this regard, Government were pleased to initiate a new scheme "SUDAKSHYA" as a pilot scheme for two years i.e. for the session 2017-18 and 2018-19 for improving Girl's enrolment in Government ITIs from existing 7% to 30% vide this Department Resolution No.5682 dated 23.11.2017. Subsequently, taking into consideration the achievement of the said pilot scheme, Government were pleased to extend such scheme for further period of 2 years i.e. for the session 2019-20 and 2020-21.

Now, taking into consideration the very objective, purpose, achievement and necessity of the aforesaid pilot scheme, Government after careful consideration have been pleased to decide for continuance of the said scheme as a regular scheme for achieving the target of 30% girls enrolment in Government ITIs, which will be reviewed after each 5 years for further continuance as per FDOM No. 9523/F dtd 22.03.2021.

The scheme shall have the following basic components:

- a. Mobilization of Girls student for admission into Government ITIs
- b. Financial support as "Maintenance Allowance" while pursuing training
- c. One time Financial Support for Post-ITI placement/Apprenticeship Training

Under the scheme the fees/charges payable at the time of admission @ Rs. 5,600/- for two years, hostel seat rent @ Rs. 1,500/- per annum, monthly maintenance allowance @ Rs. 18,000/- PA for hosteller girls and monthly maintenance allowance @ Rs. 6000/- PA for day scholar girls shall be reimbursed / paid by the Government.

Besides, for post ITI Placement/Apprenticeship, Maintenance Allowance @Rs. 12,000/- PA for apprenticeship training inside the State and Rs. 18,000/- PA for apprenticeship outside the State, and one month maintenance allowance @ Rs. 5,000/- PM for girls opting for jobs outside the State shall also be provided.

The implementing authority of the Scheme i.e. DTE&T Odisha, Cuttack shall review the said scheme in each year to achieve the very purpose of the Scheme for which it is being implemented and furnish report compliance to Government.




