RESOLUTION

Sub: Enhancement of rate of Merit Scholarship and Merit-cum-Poverty Stipend payable to the trainees of Government ITIs of the State.

- 1. Merit Scholarship is being awarded to one meritorious trainee per unit in each trade of Government ITIs @ ₹ 50/_ per month selected through a written Test to create competitiveness among the students.
- 2. Merit-cum-Poverty Stipend is being provided to 50% of the trainees of the Government ITIs of the State @ ₹ 55/- per month per trainee on roll excluding the trainees belonging to ST & SC category, who are otherwise eligible for award of Post-Matric Scholarship.
- 3. However, after careful consideration, Government have been pleased to enhance the rate of merit scholarship and merit-cum-poverty stipend payable to the trainees of the Government ITIs in the following manner w.e.f. 01.8.2012 until further orders.
- (i) The rate of merit scholarship payable to one meritorious trainee per month/ per unit in each trade selected through written test at the institute level is enhanced from ₹ 50/- to ₹ 250/- irrespective of any monetary limits of the parents.
- (ii) The rate of merit-cum-poverty stipend per student/per month is enhanced from ₹ 55/- to ₹ 200/-. The stipend shall be payable to 50% of the trainees on role excluding ST and SC trainees who are otherwise eligible for Post Matric Scholarship. The monetary limits of the parents for this purpose is enhanced from ₹ 10,000/- to ₹ 1,00,000/- per annum.
- (iii) One trainee will be eligible for one stipend or scholarship only at a time.
- 4. This supersedes Industries Department letter No. 25777/I, dated 20.9.1978, No. 23134/I, dated 07.8.1987 and No. 8074/I, dated 11.3.1988.
- 5. This has been concurred in by Finance Department vide their UOR No. 171/ES-II., dated 4.9.2012.
