NOTIFICATION

No. 59/1dt. 3/12/8

The New Examination Rules of SCTE&VT, Odisha has been circulated vide Memo No. 4645 dt. 20/11/2018. Doubt have been raised from some quarters over some provisions of the said Rule. As per the provisions in Rule 27 of the said Rules, following clarifications are hereby issued for better interpretation of the said Rules.

- 1. Admission in higher semester (from 2nd to 6th/8th(PT)) shall be allowed to those students as per clause 13.1 and Readmission in any semester(other than 1st semester) shall be allowed as per clause 14. It is clarified that, the admission to any semester other than 1st semester, shall be allowed to the students who satisfy the following conditions
 - (a) He/she must be eligible securing required percentage of attendance for the previous semester
 - (b) He/she must have Registered for Examination and must have paid Examination Fees of Full prescribed amount to the council for the previous semester.
 - (c) He/she must have passed all subjects of 1st and 2nd semester to get admission to 5th semester in addition to the above two conditions.
- 2. The students who do not satisfy the above conditions1(a) and 1(b)) are eligible for readmission whenever such semester is available in the immediate next academic session only.
- 3. Readmission in 1st semester is not allowed as per clause 14.3.
- 4. The sub-rule 5.5.1 to 5.5.8 refered in clause 13.1 may be read as 5.4.1 to 5.4.8 respectively.
- 5. The prescribed "minimum 35% marks in each theory paper including the internal assessment marks" at clause 10.1 means one has to secure a minimum of 35% marks in each Theory subject in End Semester exams. He/she is also to secure minimum 35% marks in End semester exams and Internal Assessment taken together in any subject. For Example, one has to secure minimum 28 marks out of 80 in each end semester exams and minimum 35 marks out of 100 including Internal Assessment.
- 6. The clause 14.3 bearing provision "Readmission is not allowed in 1st semester" may be read as clause 14.4 instead of 14.3
- 7. The clause 22 bearing provision "Retention period of Documents" may be read as clause 23 instead of 22
