RESOLUTION

Sub: Enhancement of rate of Merit-cum-Poverty Stipend payable to the students of Engineering Schools/Polytechnics.

1. Merit-cum-Poverty Stipend is being awarded @ Rs.200/- per month during their studies in every academic year provided they satisfy the eligibility criteria specified in sub-rule 3. The number of stipend limited to 10% of the total intake of each branch of studies subject to a minimum of 3.
2. He or She will be eligible to get Merit-cum-Poverty stipend provided his/her parents annual income from all sources is not exceed Rs.20,000/-.
3. However, after careful consideration, Government have been pleased to enhance the rate of Merit-cum-Poverty stipend payable to the students of the Government Engineering Schools/Polytechnics in the following manner w.e.f. the F.Y. 2014-15 until further orders.
 - i) The rate of Merit-cum-Poverty stipend per student/per month is enhanced from Rs.200/- to Rs.300/-.
 - ii) The stipend shall be payable to 20% of the students on role.
 - iii) The monetary limit of the parents for this purpose is enhanced from Rs.20,000/- to Rs.4.5 lakhs.
 - iv) **One student will be eligible for one stipend or scholarship only at a time.**
 - v) A student will be eligible to get stipend provided he/she has passed the last annual examination /last two semesters securing at least 60% marks.
4. This supersedes Industries Department letter No.38965/I., dt.28th Dec.,1989 and G.O. No.22176 dt.21.7.84.
5. This has been concurred in by Finance Department vide their UOR No.189/ESII dt.29.03.2013.


