- 1. The ITI Principal may depute observers at all examination centres within their Districts.
- 2. The deputation letter has to be issued to the observers by the concerned ITI Principal.
- The observer must keep the copy of letter issued and a photo Id proof while on duty at exam centre.
- 4. Trainees are appearing with original Hall Ticket & Photo Id Card.
- 5. Raw materials are provided to the trainees as per the bill of material for the question paper.
- Trainees are not involved in any mal-practices.
- Observers are empowered to debar the trainees engaged in any mal-practice & mention the same in their report.

## STANDARD OPERATING PROCEDURE (SOP) FOR DEPUTING FLYING SQUADS FOR CTS SUPPLEMENTARY SEMESTER PATTERN FOR AITT March-2024 EXAMINATION – REG.

- The deputation letter of flying squad has to be issued by Principal of Govt. Polytechnic specifying the schedule of examination and zone of visit.
- The flying squad should keep the copy of letter issued and a photo Id proof while visiting at exam centre.
- 3. The flying squad should visit the random samples of examination centres for surprise checks.
- Trainees are appearing with original Hall Ticket & Photo Id Card.
- Trainees are not involved in any mal-practices.
- Flying squads are empowered to debar the trainees engaged in any mal-practice & mention the same in their report.
